Sub: Inspection of Private ITIs in the state of Odisha.

Respected Sir,

In reference to the Letter of the DGT vide order no.: DGT-11014/2/2017-O/o DIR (TC) for constitution of Joint Inspection Team for Inspection of the Private ITIs of our state and on the basis of such direction, the State Directorate vide order no.: 8181 dated 27/06/2017 nominated one of the officer of the State Directorate to be the Associate in the said Joint Inspection Committee. We on behalf of the members of SPITIA heartily welcome such decision of the DGT for such Inspection. We also support such Inspection to maintain quality education particularly in Craftsmanship Training Course.

But, on the other hand we will humbly request you not to insist such Inspection during the starting of the academic session as the admission process is going on all the teaching and to non teaching staffs are busy in admission process of the fresh trainees. Recently, the BSE, Odisha has published the result and the candidates are taking admission and so far as other Board Exam are still waiting.

The other difficult part is that the AITT 2<sup>nd</sup> and 4<sup>th</sup> Semester Examination has been scheduled to be start from 2<sup>nd</sup> week of July 2017 and it will continue till 2<sup>nd</sup> week of august, therefore it is practically not possible for the individual Institution to Cooperation with such Inspection team and if such Inspection is carried out during the above period ultimately, it will not only disturb the admission and the AITT Examination but also it will affect the carrier of the poor trainees of the rural locality of our state and not only that, it will cause heavy financial burden to the individual Institute for which they will face humiliation from Banks.

Therefore, in view of the above mentioned facts and circumstances, we on behalf of the members of SPITIA request your good office to take a conscious decision to fix a suitable date and to revise the schedule for such Joint Inspection after completion of Admission and the AITT July-2017, i.e in the month of October. Further, we would like to request you to prepare a detail calendar for such inspection and further request you that, prior notice to be issued to the Individual Institution before conducting such Inspection in the respective institution, as it will put into difficulty to the institution concern.

We hope and trust that your good office will take appropriate and necessary steps for the greater interest of the student and institution at large.
